Modernization of Local Public Services in the Republic of Moldova

- Based on bilateral government negotiations Moldova-Germany
- Phase 1: 1/2010 12/2015;
- Phase 2: 01/2016 12/2018; extension foreseen until 12/2020
- Main Institutional Counterpart: Ministry of Regional Development and Construction (MRDC) and the Regional Development Agencies (RDAs) North, Center, South and ATU Gagauzia
- Technical Assistance provided by : GIZ on behalf of the German Ministry for Economic Cooperation and Development (BMZ)






Framework conditions of MLPS

- Implementation of 3.7 million EUR Swedish-co-financing started
- EU 3.5 million EUR co-financing is signed by both parties and implementation started
- EU 39.8 million EUR co-financing is under finalization and signatures are required by August, 2017
- Successful Bilateral Government Consultations Germany Moldova carried out; agreement of further BMZ-increase to MLPS; pending exchange of diplomatic notes on previous BMZ-commitments
- Request to BMZ on extension until 12/2020 is submitted
- Upcoming change of Project Manager/Country Director

Intervention Area I: Support in Coordination of Regional **Development Policy**

Achievements during January – June 2017

- National Strategy for Regional Development 2016-2020 was published in the Official Gazette No. 30-39 dated 03.02.2017
- Action Plan for the National Strategy for Regional Development 2016-2020 was developed and approved by National Coordination Council for Regional Development and Government
- New draft Law on Regional Development was developed and submitted to the Minister of Regional Development and Construction for initial approval and further public consultations





Intervention Area I: Support in Coordination of Regional **Development Policy**

Achievements during January – June 2017

- Draft Monitoring & Evaluation framework of National Strategy for Regional Development 2016-2020 was approved by National Coordination Council for Regional Development and is undergoing consultations with line ministries and RDAs
- Support to Parliamentary Commission for Public Administration, Regional Development, Environment and Climate Change started



Intervention Area I: Support in Coordination of Regional Development Policy Next steps during July - December 2017

- New draft Law on Regional Developed is launched for public consultations
- Implementation of National Strategy for Regional Development 2016-2020 is subject to public consultations and awareness by the Parliamentary Commission for Public Administration, Regional Development, Environment and Climate Change
- Results-based monitoring framework for the National Strategy for Regional Development 2016-2020 and Regional Development Strategy is in place.
- Facilitation on policy coordination related to EU 39.8 million EUR cofinancing is provided

Intervention Area I: Support in Coordination of Regional Development Policy

Next steps during July - December 2017

- Analysis and advice on synergizing the National Fund for Regional Development, National Ecological Fund and Energy Efficiency Fund and local investment budgets is provided
- Draft regulation of the new Ministry of Agriculture, Regional Development and Environment is developed
- Implementation of the MRDC Communication Strategy is carried out

Intervention Area II: Support to Regional Development Councils

Achievements during January – June 2017

- Draft regulations for the Regional Sector Commissions developed by working groups from each Regional Development Council
- Formal decision by Regional Development Councils regarding establishment of Regional Sector Commissions is expected by June 2017
- As agreed during the last MLPS Steering Committee, sectoral ministries are expected to designate representatives to co-chair the Regional Sector Commissions
- International and national short term expert pool to support citizen engagement in the delivery of local public services has been established





Next steps July – December 2017

- One Civil Society Organization/Consortia in each Development Region is to be selected to improve transparency and accountability of public services projects
- EU is considering an additional contribution of 5 million EUR for upscaling the above approach
- Local Public Authorities is supported via Civil Society Organization/Consortia on local planning, awareness raising and inter-municipal cooperation using participatory methods
- Water Supply and Sanitation and Energy Efficiency in public buildings regional sector programmes for ATU Gagauzia are developed
- Consulting/expert pool to support Regional Sector Commissions in development and implementation of the regional sector plans is established

Intervention Area III

Support to Regional Development Agencies







Achievements during January – June 2017

- Costesti waste water treatment plant, Cahul drinking water purification plant and Rosu canalization are completed
- Multipartite agreement regarding Cahul Lebedenco Vulcanesti Water Supply and Sanitation project is reached and technical design company selected
- Due diligence procedures regarding 10 Water Supply and Sanitation and 8 Energy Efficiency in public buildings public services projects are completed; related technical design themes are under development
- Final draft of "Implementation Manual for investment measures using EU funding" is completed and will be circulated for final comments

Intervention Area III: Support to Regional Development Agencies

Achievements during January – June 2017

- Contract package for EU 3.5 million EUR co-financing is completed and signed
- Pre-final draft of contract package for EU 39.8 million EUR is completed
- Romanian co-financing for Rosu canalization connections is extended to June 2018
- Extension of German Fund for Regional Development until December 2018 is requested; formal approval is pending.





Intervention Area III: Support to Regional Development Agencies

Next steps July - December 2017

- Contracted technical design services for Swiss Agency for Development and Cooperation / EU financed Cahul-Lebedenco Water Supply and Sanitation project (0.330 million EUR)
- Tender for construction of Leova-Iargara WSS project (3.5 million EUR) is launched
- Tender for Calarasi Hospital Energy Efficiency in public buildings project is relaunched





Intervention Area III: Support to Regional Development Agencies

Next steps July - December 2017

- "Implementation Manual for investment measures using EU funding", incl. new procurement regulation is completed and introduced to RDAs and private sector
- Kick-off of implementation of EU 3.5 million EUR co-financing
- Tenders for 18 technical design projects are launched
- Finalization and signature of contract package for EU 39.8 MEUR

Intervention Area IV

Institutionalisation of Trainings and Capacity Development







Achievements during January – June, 2017

(1) Institutionalisation of Demand-oriented Training Modules

- Training methodology in the Water Supply and Sanitation and Energy Efficiency in public buildings completed and validated
- 3 training modules are piloted ("Regional Marketing" with APA; "Human Resources Management" and "Investment Projects" for Water Supply and Sanitation operators with Technical University of Moldova)
- 7 previously developed training modules reimplemented (160 participants, 71% female)





Achievements during January – June, 2017

(2) Support Organisational Development of Training Institutions

 Development of two Action Plans for Institutional Development of training institutions complemented and implementation initiated

(3) Support to Exchange and Networking

- 3rd Local Government Open Forum on 'Modernisation of Local Public Services' organised by APA on 29 March
- Study visit for design companies to Romania in partnership with the Chamber of Commerce and Industry organized





Next steps during July - December, 2017

(1) Institutionalisation of Demand-oriented Training Modules

- 4 new training modules piloted ("Public Property Management" with the Academy of Public Administration; "Public Procurements" for Water Supply and Sanitation operators with Technical University of Moldova; 2 modules in the field of energy efficiency / Technical University of Moldova)
- 7 previously developed training modules re-implemented





Next steps during July - December, 2017

(2) Support Organisational Development of Training Institutions

 Prioritised measures from the Action Plans for Institutional Development of training institutions are implemented

(3) Support to Exchange and Networking

- 4th Local Government Open Forum organised by the Academy of Public Administration
- (Inter-)National Conference in the Water and Sanitation Sector is organised
- Exchange between Moldova, Georgia and Ukraine on "Regional Development" chapters in the EU-Association Agreement is initiated











- With reference to the Law on Regional Development, lack of certainty regarding future role/mandate of Regional Development-institutions, their relation to future combined ministries
 - Recommendations/decisions: To work in close coordination with Centre for Implementation of Reforms
- Lack of certainty on future composition/mandate of National Coordination Council for Regional Development /MLPS Steering Committee
 - Recommendations/decisions: To develop a proposal on new Steering Committee set-up in accordance with the new Government structure.

- Overlapping support to Cahul/Vulcanesti Water Supply and Sanitation project in Gagauzia
 - Recommendations/decisions: Water Supply and Sanitation
 - Representatives of ATU Gagauzia to confirm that Vulcanesti will use the water pipeline Cahul –Vulcanesti as a default source of water; TIKA support exclusively for creation of back up option
 - To include representatives of Turkish Cooperation and Coordination Agency and Vulcanesti in the Local Steering Committee

Intervention Area II: Support to Regional Development Councils (1)

- Clarification of the issue for compensation of expenses of members of the Regional Development Councils is pending
 - Recommendations/decisions: To carry out an analysis of related legal framework and provide recommendations for necessary legal/normative amendments to ensure payment of sitting allowances for Regional Development Council members
- Secretariat services for Regional Sector Commissions are required
 - Recommendations/decisions: Regional Development Agencies with support of MLPS to ensure secretariat services for Regional Sector Commissions





Intervention Area II: Support to Regional Development Councils (2)

- Limited public confidence in procurement processes
 - Recommendations/decisions: To promote citizen engagement by providing toolkits to local citizen committees to raise awareness and increase social accountability





- Additional support to RDAs involvement in EU co-financing is under discussion
 - Recommendations/decisions: Encourage MRDC & RDAs to agree on the presented concept
- Low number/quality of bids and need for substantial increase of outreach activities
 - Recommendations/decisions: To provide support related to private sector capacity development measures via Chamber of Commerce and Industry and professional associations

Intervention Area III: Support to Regional Development Agencies (2)

- Tight timeline for implementation of the Swiss Agency for Development and Cooperation financed Cahul-Lebedenco Water Supply and Sanitation component
 - Recommendations/decisions: SDC to consider extension of implementation timeline of SDC co-financing to 12.2018
- Riscani/Costesti Water Supply and Sanitation project due Diligence Procedure requires changes of the foreseen scope of EU financed measures
 - Recommendations/decisions: MLPS to identify feasible solutions within the available budget jointly with the partners





- Leova Water Supply and Sanitation project Due Diligence Procedure and partner discussions require changes of the foreseen scope of EU financed measures
 - Recommendations/decisions: Leova Council to present the request for changes for the approval of the Regional Development Council and ultimately, National Council for Regional Development

- Solid Waste Management trucks Floresti pending criminal investigation blocs spending of earmarked funds:
 - Recommendations/decisions: To develop a scenario B for reallocation of funds and consider its application, depending on the result of the investigation.
- Cahul distraint of vehicles by authorities
 - Recommendations/decisions: Request involved fiscal institutions to address the issue without targeting donor financed means and release vehicles from distraint

Intervention Area IV: Institutionalisation of Trainings and Capacity Development

- Lack of realistic scenario for sustainable financing of developed training modules after end of MLPS-support
 - Recommendations/decisions: To elaborate an exit strategy with each training institution to ensure sustainability of the developed training modules
